## Genealogy Steps

Please do *not* bring or send any original documents. They will *not* be returned to you.

1. Call for appointment; bring all documentation you have to prove your ancestry. First document needed your long form birth certificate; this record has both your parents listed on it. If you do not have your long form birth certificate, it can be obtained from the department of vital statistics in the province in which you were born.

Or

An acceptable alternative, if applicable, is your baptismal or christening record, as this is a record that has your parent's names on it. It may be obtained from the church where you were baptized or christened, or from the Archdiocese of the church.

2. Obtain a copy of the long form birth certificate of the parent whom you are verifying Métis ancestry through. This is a record with your parents name on it. If you do not have your parents long form birth certificate, it can be obtained from the department of vital statistics in the province in which they were born.

Or

An acceptable alternative, if applicable, is their baptismal or christening record. This may be obtained from the church where they were baptized or christened, or from the Archdiocese of the church.

If your parent is deceased:

As the living next of kin, you are eligible to apply for this information from the above agencies.

3. Please send a copy of your genealogy, which must go back to at least the 1901. Use the 5-generation pedigree chart included with the application package forms. Include as much information as possible, i.e. Birth dates, birthplaces, marriage dates and places, death dates and places. Without these specific details the office of FVMN may not be able to verify your genealogy. Always use maiden names for women when completing the chart.
4. In addition to your long form birth certificate, please send a copy of at least one other form of identification, such as: BC driver's license, BC voters card, BC Identification card, BC care card, or passport.
5. A recent color photograph (head shot) is required. This should be of the size and quality of a passport photo. Any others are not acceptable.
6. There is a \$65.00 fee to cover the costs of all related expense of the card. Please include a cheque or money order with each application package. Please make payable to and mail to [info@fvnm.ca](mailto:info@fvnm.ca)
